- You will be issued a key for your locker, and it must be returned upon termination of membership. There will be a \$20.00 charge for lost keys.
- Main Street Cigar Lounge has the right to access any locker at any time necessary by Staff or by law.
- Management reserves the right to close the lounge on occasion for any purpose or function.
- Management reserves the right to open the lounge to the public for any purpose or function.
- Management reserves the right to suspend or revoke a membership for non payment of bill, breach of contract, misconduct, or failure to adhere to any of the rules, regulations, and policies set forth by Main Street Cigar Lounge.
- Main Street Cigar Lounge reserves the right to suspend access to any locker for 30 days due to non-payment. If non-payment exceeds 60 days, Main Street Cigar Lounge, Inc. reserves the right to seize contents of locker and terminate membership.
